



## Autodesk Prices First Sustainability Bond Offering

SAN FRANCISCO, Oct. 5, 2021 (PRNewswire) – Autodesk, Inc. (NASDAQ: ADSK) today announced the pricing of its first sustainability bond offering of an aggregate principal amount of \$1 billion in 2.4% senior notes due 2027. The offering is expected to close on October 7, 2021, subject to the satisfaction of customary closing conditions.



Autodesk intends to allocate an amount equal to the net proceeds from the sustainability bonds to finance or refinance, in whole or in part, certain eligible projects related to both environmental and social initiatives, including: Eco-Efficient Products, Production Technologies and Processes, Sustainable Water and Wastewater Management, Renewable Energy and Energy Efficiency, Green Buildings, Pollution Prevention and Control and Socioeconomic Advancement and Empowerment.

Both Securities, Inc., Morgan Stanley & Co. LLC and U.S. Bancorp Investments, Inc. are acting as joint book-running managers for the offering.

This offering is being made under an effective shelf registration statement on Form S-3 filed with the Securities and Exchange Commission (the "SEC") on September 2, 2020.
